- We are facing an uncertain and complex global economic and financial environment.
- Economic growth is very low and some of the economic industries are in distress;
- Unemployment is high and job creation far below the job creation targets;
- As outlined in the 2017 SOPA, most of the poverty and inequality indicators improved in recent years, and
- The government social grants cover 1.43 million people in Mpumalanga, which is a third of the population of the Province.

Growing the provincial economy and addressing the triple challenges remain a top priority for the Mpumalanga Provincial Government.

For this reason, the provincial government will accelerate action and implement economic plans to change the lives of all our people, specifically targeting youth, women and People with Disabilities.

We will consolidate the implementation of the Nine Point Plan with the aim to "attract investment, accelerate service delivery and drive economic growth and transformation".






