Category 2 (One-year agreement / Agreement expiring): Organisations with whom the Department entered into a one-year SLA during April 2021, and who wishes to reapply for funding OR Organisations with whom the Department entered into a three year SLA, of which the SLA is expiring March 2021	 All the above Organisation to submit a <u>Progress Report</u> by 15 November 2021 as per SLA 		
Category 3 (Valid multi-year agreement): Organisations with whom the Department entered into a three year SLA, of which the SLA is still valid	 Organisation does not have to resubmit a Business Plan for the 2022 financial year Organisation to submit a Progress Report by 15 November 2021 as per SLA
