

# EXPRESSION OF INTENT TO EXPAND GRADES AND CURRICULUM AT REGISTERED INDEPENDENT SCHOOLS

## 1. PURPOSE

The purpose of the *Expression of Intent to expand Grades and Curriculum at Registered Independent Schools* is to supplement the completed registration processes of independent schools who intend to expand the curriculum of the school after it had been registered, and to provide for a common format to owners to make their intention known to the Mpumalanga Department of Education, by providing a broad outline of the envisaged expansion of the grades and curriculum.

## 2. SUBMISSIONS OF EXPRESSION OF INTENT TO EXPAND GRADES AND CURRICULUM AT REGISTERED INDEPENDENT SCHOOLS

- 2.1 The *Expression of Intent to expand Grades and Curriculum at Registered Independent Schools* must reach the relevant Circuit Manager **not later than the end of February** of the year preceding the next academic year. No late submissions will be considered.
- 2.2 Submission of the *Expression of Intent to Expand Grades and Curriculum at Registered Independent Schools* would lead to a written invitation **before the end of March** of the year preceding the next academic year to the owner(s) of the registered independent school by the relevant Circuit Manager to a Preparatory Meeting, during which the owner



will be guided on all legal and other requirements pertaining the expansion of grades and curriculum, the procedures and related time frames and on populating the *Application to Expand Grades and Curriculum at Registered Independent Schools.* 

# 3. COMPLETION OF THE EXPRESSION OF INTENT TO EXPAND GRADES AND CURRICULUM AT REGISTERED INDEPENDENT SCHOOLS

- 3.1 The Expression of Intent to Expand Grades and Curriculum at Registered Independent Schools must be fully completed before being submitted. A fully completed document means that Sections A, B and C of form 24/2013 must be completed and all the required attachments will accompany the Expression of Intent to Expand Grades and Curriculum at Registered Independent Schools. All the applicable boxes must be populated in either black/blue ink.
- 3.2 An *Expression of Intent to Expand Grades and Curriculum at Registered Independent Schools* must be completed for each site separately should you intend to apply for the expansion at more than one independent school. The same document cannot be used for satellites/subsidiaries/branches, etc.

## 4. STATUS OF AN EXPRESSION OF INTENT TO EXPAND GRADES AND CURRICULUM AT REGISTERED INDEPENDENT SCHOOLS

The submission of the *Expression of Intent to Expand Grades and Curriculum at Registered Independent Schools* does not mean that it replaces the *Application for the Expansion of Grades and Curriculum at Registered Independent Schools.* It serves as the first step towards an application to expand grades and curriculum still to be made.


## 5. CONFIDENTIALITY

(i.e.: Describe how the envisaged expanded grades and curriculum will meet a need and any potential clients identified as having that need).



3. Detail your prospective customer base and target demographic. Describe your evaluation of your competition and your market research test results.


4. Outline your marketing strategy and the tools you would use to recruit potential learners for the envisaged expanded grades and curriculum.

5. Outline the nature of facilities that will be available for the envisaged expanded grades and curriculum.



6. Elaborate on the educator staff profile that you intend to appoint and how they will be recruited for the envisaged expanded grades and curriculum.

7. Estimate any tentative risks, such as an assessment of competition or prospective competition, and their anticipated response to the envisaged expanded grades and curriculum, and/or the potential for conflict among alternative community institutions within the proposed project area, etc.



- 8. Attach proof of financial viability (e.g. audited financial statements) to demonstrate that you, as the owner(s), in terms of financial resources, will be able to establish and maintain the envisaged expanded grades and curriculum at your own cost, without putting any prospective learner at risk in terms of their educational development, because of possible financial insecurities of the prospective owner(s).
- 9. In the case of previous insolvency, documented evidence of rehabilitation from insolvency must be provided.
- 10. Attach a comprehensive financial plan, indicating the capital needed to cover start-up costs and capital needed for expansions planned for. Show a realistic two-year forecast, based on macroeconomic conditions, of projected revenue and earnings, as well as projected expenditure. Demonstrate how you will reach cash flow positive status.
